Liability Insurance:

On 1/24/13 – John Wellwood executed the renewal of our insurance policy with American Specialty - Premium at \$448.50

192 members at \$2.31 per member – \$1.55 rise in cost for last year

Our insurance policy, as it was last year, contains 13 restrictions. The most noteworthy are:

- Our rides are not open to individuals other than members and first time invited guests.
- We do not organize or operate tours that are commercial in nature.
- As a reminder, our relationship with American Specialty requires membership in the LAB (League of American Bicyclist). This membership expires 7/1/2013 and it should be renewed before then.
- LAB Yearly Membership due in July 2013 \$50.00 (approx) –

Website – Karl Rudnick – Karl will provide email forwarding from website emails to board members. Board members will have access to member database.

SDCBC (San Diego County Bicycle Coalition) - They have changed their structure for meetings. Subcommittees have been set up that meet more often and regular meetings will be quarterly. This allows clubs to get more attention. They hope this will allow more interaction with clubs. Karl is on the council for bike and pedestrian committees. Advocate and Development subcommittee - Ed Clancy.

Roadies – Jeff Gross– Discussion of changing routes or altering for a bonus ride for March 23rd ride to show support for Sharrows in Solana Beach and Encinitas.

Long Riders – Karl Rudnick – Karl has been in touch with Tour of California and has need for volunteers May 12- 19. Karl volunteered to head up training for course marshals and volunteers.

Old Business

- Discussion was made and it was clarified that first time riders must sign in prior to the ride. Minors are able to ride with the group but must be accompanied by an adult and sign in as well. Membership is required for all riders to continue riding with the group.
- Discussion whether every rider should carry accident claim forms or just the ride leaders.
- Need to send for updates to waivers.
- Question whether there is a link to access the forms?
- Karl suggested making a call to the insurance company to discuss clarification procedures for identifying and filing claims.
- John Wellwood has approved the group for additional liability coverage of \$1M that would cost an additional \$75/yr. A motion was made by Dolores to approve and was 2nd by Maria with unanimous agreement. Motion is subject to further information.
- We are to get back to John Wellwood regarding the additional liability coverage of \$1m.

New Business:

- Discussion was started by Peg regarding group riding etiquette. When riding in a group and go through a light should wait for the next group that missed. Peg suggest just cross it off rules of Etiquette. Other discussion was made about leaving riders behind and that we should buddy up with other riders.
- Peg requested format of docs submitted as .xls files.
- The Saris Cycle Group will put a free bike coral in any place that can be recommended and approved. Someone needs to look into details.
- Next bicycle education safety classes are Friday, April 5th for Urban Bicycling Part 1 and Road Skills, Part 2 is Saturday April 13th.

New Kit update.

The Kit Store opened 1 week late and at this time 39 pieces have been ordered. It was suggested that another reminder that the store is open is sent to membership. Mention was made that the \$10 discount is included in the prices. We may have to keep store open for an additional week to get more orders.
